

## End User Licence Agreement for Serpentype Trial Fonts

This End User Licence Agreement (hereinafter «Agreement») is a legal Agreement between you, or, if you represent a legal entity, that legal entity (hereinafter «you») and Serpentype, and is applicable to the Font Software (Trial Fonts) that is accompanied by this Agreement or that you have ordered.

By downloading, installing and/or embedding the Font Software, you agree to be bound by the terms of this Agreement. If you do not agree to the terms of this Agreement, do not order, install, or use the Font Software.

### 1. Definitions

«Font Software» means coded software that generates typeface designs when used with the appropriate hard- and software plus any and all other data including documentation provided with such software.

### 2. Trial Font Restrictions

You may not create products with the Font Software to be used commercially, or personally. Products created with the Font Software are for testing and evaluation purposes only.

You may not embed the Font Software in any products or webpages that are publicly accessible without prior written consent from Serpentype. Please contact [hello@serpentype.com](mailto:hello@serpentype.com) for further information.

### 3. Third Parties

You may not provide the Font Software or make it accessible to any other third parties.

### 4. Modifications

You may not modify, adapt, translate, reverse engineer, decompile, disassemble, or create derivative works based on the licensed Font Software itself without Serpentype's prior written consent.

### 5. Copyright

The Font Software and the accompanying materials are copyrighted and contain proprietary information and trade secrets belonging to Serpentype owning the Font Software. Unauthorized copying of the Font Software even if modified, merged, or included with other software, or of the written materials, is expressly forbidden. You may be held legally responsible for any infringement of Serpentype's intellectual property rights that is caused or encouraged by your failure to abide by the terms of this Agreement.

### 6. Termination

This Agreement is effective until terminated. This Agreement will terminate automatically without notice from Serpentype if you fail to comply with any provision contained herein. Upon termination, you must destroy the written materials, the Font Software, and all copies of them, in part and in whole, including modified copies, if any.

### 7. Upgrades

Serpentype may, from time to time, update the Font Software.

## 8. Disclaimer and Limited Warranty

Serpentype warrants the Font Software to be free from defects in materials and workmanship under normal use for a period of twenty one (21) days from the date of delivery. Serpentype's entire liability and your exclusive remedy as to a defective Font Software shall be, at Serpentype's option, either return of purchase price or replacement of any such Font Software that is returned to Serpentype with a copy of the invoice. Serpentype shall have no responsibility to replace the Font Software or refund the purchase price if failure results from accident, abuse or misapplication, or if any Font Software is lost or damaged due to theft, fire, or negligence. Any replacement Font Software will be warranted for twenty one (21) days.

EXCEPT AS EXPRESSLY PROVIDED ABOVE, THE FONT SOFTWARE, IS PROVIDED «AS IS». SERPENTYPE DOES NOT MAKE ANY WARRANTY OF ANY KIND, EITHER EXPRESSED OR IMPLIED, INCLUDING, BUT NOT LIMITED TO THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.

The entire risk as to the quality and performance of the Font Software rests upon you. Serpentype does not warrant that the functions contained in the Font Software will meet your requirements or that the operation of the software will be uninterrupted or error free.
